

#### **Motion #1** (by Pam Turnbull)

Motions that Canadian Scottish Athletic Federation (CSAF) establish an official, centralized communication platform — such as a monitored chat room, online forum, or expansion of the existing CSAF Facebook page — to facilitate the sharing of accurate and timely information relevant to Heavy Athletes and Games organizers.

#### Justification:

To create a reliable “one-stop” location where athletes, organizers, and officials can access and share important information, including (but not



limited to):

- Registration processes for Heavy Athletes and Games participation;
- Contact information for Games organizers;
- Posting and updates of upcoming Games across regions;
- Discussion and sharing of official CSAF announcements and opportunities.

Details and Recommendations:


- The platform may be hosted through an existing channel - the CSAF web page
- The platform should be monitored and moderated by designated Subject Matter Experts (SMEs) or approved CSAF representatives to ensure accuracy, respect, and professionalism in all postings.
- All information shared should be fact-checked and verified prior to public posting to maintain credibility and trust.
- I am willing to assist with the maintenance and monitoring of this communication platform if approved.

Rationale:

Many athletes and Games participants currently experience challenges accessing consistent and accurate information regarding competitions, registration, and contact points. By centralizing communications in an official CSAF-monitored space, we can increase transparency, community engagement, and support for all athletes — including those who are not active on Facebook or other social media platforms.

Justification:




**Motion #3** (by Karyn Dallimore)

Motions that all championship bids and athlete applications for championships must be submitted using the Google Forms that are posted in order to be considered. If they arrive by any other means they are to be




considered not valid. A CSAF representative will attempt to contact the submitter of the invalid bid/application and advise them to resubmit using the correct format.
